

ARTSQUARED 2018 | CALL FOR ARTISTS

ARTWALLA SEEKS ARTISTS FOR SMALL WORKS AND GALLERY SHOW AND SALE

ArtWalla is issuing a Call for Artists to participate in ArtSquared, a small works and gallery show and sale to be held September 28 - 30, 2018 at CAVU Cellars, 175 E Aeronca in Walla Walla, 99362.

Artists are being sought to produce 10 original works each on 6X6 inch wooden art boards supplied by ArtWalla. ArtSquared will ultimately feature hundreds of pieces of original art. Each piece of art will sell for \$36 with a portion benefiting ArtWalla and the organization's commitment to art education.

Each artist participating in the 6x6 event is also invited to show one 2D or 3D creation in CAVU Cellars events/gallery space until October 28, 2018. Prices for these pieces will be set by the artist. A 20% commission will be paid to ArtWalla for sales during the opening event on September 28th; 20% commission will be paid to CAVU Cellars for sales made during the duration of the show.

- Artists must be over 18 years of age or older.
- Entry fee is \$30. For ArtWalla Working Artist member, the discounted entry fee is \$5.
- ENTRY DEADLINE IS MONDAY, APRIL 30, 2018. Limited space available, registration will be closed early if registration is full. Registrations received after the limit is reached will be placed on a waiting list.
- The registration must be completed online or postmarked by the entry deadline.
- Registration can be completed online at www.artwalla.com or by completing the attached registration form and mailing it to ArtWalla, PO Box 2192, Walla Walla, WA 99362.

- Weekend Sale:** Saturday and Sunday, September 29th and 30th - 11 a.m. to 4 p.m.
- Eligibility:** Open to artists age 18 and over
- Entry Fees:** \$30 for Non-members.
\$5 for current Artist Level Members of ArtWalla.
Ten (10) art panels are provided by ArtWalla to all registered participants.
- Shipping** Out of town artists with no local contact to pick up panels or return unsold 6x6 art may pay an additional fee of \$20 for shipping and handling
- Entry Deadline:** April 30, 2018 or earlier if show is full – limited space available.

TERMS AND CONDITIONS

Small Works Show – September 28, 29, and 30, 2018

Artist commits to submitting 10 pieces. All work must be created on and fit within the 6x6 inch wooden art panel supplied by ArtWalla with your registration. 3D work is acceptable on the panel and must not exceed a depth of 2", including the panel. All work is unframed and will be displayed with no two pieces by the same artist in close proximity.

Each panel will be priced at \$36; for each panel the artist sells, they will receive \$24 and \$12 will go to ArtWalla. ArtWalla's share of the proceeds will support arts education and future art events. Artists may choose to donate all proceeds to the fundraiser. Your donation is tax-deductible.

Gallery Show – September 28 through October 28, 2018

Artists participating in the Small Works show and sale may choose to enter one larger format piece in the Gallery Show. Gallery pieces may be 2D or 3D. There is no additional fee to participate in the Gallery show.

2D pieces must be wired for hanging and no larger than 24 inches in any direction. 3D pieces must be no larger than 24 inches in any direction and weigh no more than 40 pounds.

Prices will be determined by the artist. A 20% commission will be paid to ArtWalla if pieces are sold the opening night. A 20% commission will be paid to CAVU Cellars if pieces are sold during the remainder of the show. When art is sold, the artist will be notified and may replace it with comparable work for the duration of the show.

All artwork must be original in interpretation and composition, not copied from copyrighted or published art and appropriate for general audiences. ArtWalla reserves the right to reject work that is deemed inappropriate, indecent, or unsafe to display. ArtWalla reserves the right to use images of artwork on our website and in promotional materials; artwork may also be photographed for use by the media. Please make us aware of any restrictions in writing at the time of registration. Each board will be labeled on the back to include artist's name, title of work, and medium. All artwork must be dry at time of delivery.

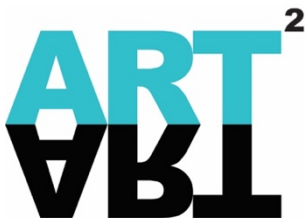
